

Amendment of  
the principal law  
with the addition  
of the new  
Regulation 20D.

5. The principal law is hereby amended, immediately after Regulation 20C, with the following new Regulation:

C

«Conducting civil weddings. Sixth Appendix. 20D.-(1) Regardless of the provisions of Regulations 20, 20A, 20B, and 20C, a Museum or Ancient Monument specified in the Sixth Appendix may be used for civil weddings.

Sixth Appendix. Seventh Appendix. (2) The use of Museums or Ancient Monuments in Appendix Six for civil weddings requires the submission of an application to the Antiquities Department, via the respective Municipality, at least (1) month prior to the intended wedding date, in the form included in the Seventh Appendix.

Eighth Appendix. (3) During the examination of every application for the use of a Museum or Ancient Monument for the purpose of performing a civil wedding, the Director is authorised to:

(a) ask the applicant to amend their application or any of its details, especially the date or the time of the wedding ceremony.

(b) reject the application submitted.

- (c) grant the license for use subject to terms, conditions, or covenants which the Director from time to time, deems reasonable or necessary.
- (d) impose the payment of the usage fee specified in the Sixth Appendix, before the marriage takes place.
- (e) impose the submission of a letter of guarantee or a security deposit up to eight hundred and fifty Euro (€850,00):

The Director is authorised to keep part or the entire security deposit in instances whereby the terms, conditions or covenants specified in the stipulated Regulations are not met or adhered to, which he has the authority to set when granting the permit for the use of Museums or Ancient Monuments for the purpose of a civil wedding ceremony in accordance with the provisions of the stipulated Regulation.

(4) The use of Museums or Ancient Monuments for civil weddings, included in the Eighth Appendix, is only allowed after a permit is granted by the Director, presented in writing to the individual who has submitted the relevant application, provided that:

- (a) the Museum or Ancient Monument is available and will not be used for another event.
- (b) the ceremony will be conducted during the operating times of the given Museum or Ancient Monument.

Sixth Appendix.

(5) every person granted permission to use a Museum or Ancient Monument specified in the Sixth Appendix, for the purpose of conducting a civil wedding, must fulfill the obligations specified in the provisions of paragraph (1) of Regulation 20A, with the exception of the specified provisions of subparagraph (ζ) (F) of the aforementioned regulation, in addition addition to the following obligations:

- (a) ensures that the number of people attending the civil wedding ceremony is limited to the respective number specified for every Museum or Ancient Monument in the Sixth Appendix.
- (b) ensures that no flowers, rice, or confetti are thrown, nor are any flares or fireworks lit, or any other kind of object or material thrown during the civil wedding ceremony.

(6) Any violation of the provisions of paragraph (5) is punishable, if convicted, with a fine not in excess of seven hundred and fifty euro (€750,00) for each day, or part of the day during which the violation takes place.

For the purposes of this Regulation, the term «ceremony» means the performance of a civil wedding.
